# Earthwatch COVID-19 Disclosure & Acknowledgement Form

Earthwatch is pleased to welcome you into the field to participate in hands-on field science. Before you join one of our expeditions or programs, we want to be sure you understand how we are responding to the coronavirus pandemic so you can make informed decisions about whether you feel comfortable to participate. The risk of contracting COVID-19 (the disease caused by SARS-CoV-2) or related variants cannot be eliminated but we are taking steps to reduce transmission.

Earthwatch collaborates with our scientists and partners around the world, and continually monitors health and travel guidance from trusted authorities such as the U.S. Centers for Disease Control and Prevention (CDC), the U.S. State Department, the World Health Organization (WHO) and the independent company that advises us on international security issues. We will use this guidance and our best judgment to make changes to our expeditions or programs in order to reduce the risk of COVID-19 (or other illnesses) for our participants, staff, scientists, field staff and the local communities in which we work.

While the public health emergency has ended, COVID-19 remains an evolving risk to our participants, scientists and the communities in which we work. Our requirements, decisions and practices may change at any time, including at the last minute or during your expedition or program, as we learn new information or recommendations from authorities change. Please contact Earthwatch if you have questions about your specific program.

## **VACCINATIONS**

Proof of full vaccination against COVID-19 is required for all Team members on Earthwatch expeditions and programs.

This includes all participants (volunteers, fellows, adults, and teens), facilitators, Earthwatch scientists, Field Team Leaders, and Earthwatch staff. Please note that Earthwatch does not collect proof of vaccination from support staff (e.g., field rangers, cooks, visitors, service providers, etc.) or local community members; as such we are not able to verify that everyone you could potentially come into contact with will be vaccinated. Proof of full vaccination must be provided to Earthwatch prior to participation. If you arrive at your expedition or program without having done so, you will not be allowed to participate until you can provide Earthwatch with verification of your full vaccination.

As per CDC guidance, people are considered fully vaccinated for COVID-19 two weeks or more after they have received:

1.) all required doses of a primary vaccine series authorized by the U.S. Food and Drug Administration (FDA) or the World Health Organization, or 2.) a single dose of the updated bivalent Pfizer-BioNTech or Moderna COVID-19 vaccine, received any time after September 2, 2022. When a participant or field staff resides in a country where FDA or WHO-approved vaccines are not available, but they have received a vaccine that is locally available, Earthwatch will assess the situation on a case-by-case basis.

Earthwatch strongly encourages you to stay up-to-date with your vaccinations, including booster doses if available.

### **BEFORE FIELDING**

We recommend that you continue to take steps to limit your exposure prior to your program, such as wearing a mask, during the entire journey to the program site. We highly recommend that everyone, particularly those at a higher risk of severe illness from COVID-19, consult with their health care provider about whether to participate in an Earthwatch expedition or program at this time.

If you are experiencing COVID-like symptoms in the days before your Earthwatch program, please get tested prior to travelling. Do not travel to your Earthwatch expedition or program if you have tested positive for COVID-19.

In the event of a cancellation due to a documented positive test for COVID-19, you will have the option to transfer to another expedition or transfer your funds into an Expedition Fund that you can use towards a future Earthwatch Expedition within the next three years. We will always work with you based on your individual situation.

#### PRECAUTIONS DURING THE PROGRAM

If local conditions or recommendations from authorities change, additional requirements may be implemented. Your specific expedition or program may have additional rules or recommendations regarding COVID-19. Please consult your Online Expedition Briefing and Expedition Logistics Document before participating for more information.

You may be required to take certain precautions while in the field, such as wearing masks, frequent hand-washing and physical distancing. You must bring a thermometer, multiple face masks and hand sanitizer with you for your personal use in case they are needed. Masks rated as more effective (such as N95 or equivalent) are strongly recommended.

The use of face masks will be mandatory when: required by law; requested by program leaders or service providers (such as accommodations or transport providers); or deemed appropriate based on local conditions.

Earthwatch supports a mask-friendly environment on all programs and any individual who wishes to continue to mask will be supported in that decision.

#### IN THE EVENT OF SYMPTOMS OR A POSITIVE TEST DURING THE PROGRAM

You will be expected to monitor your own health on a daily basis and report any COVID-like symptoms to program staff right away. We may ask you to get tested and/or seek medical advice. Testing requirements, distance, availability and cost vary by location. You will be responsible for the cost of any testing and, if needed, additional transport to testing.

Anyone who displays symptoms of COVID-19 or tests positive for COVID-19, upon arrival or during an Earthwatch program, may be required to isolate/quarantine in accordance to local or CDC guidelines. Depending on the circumstances of the expedition, isolation/quarantine may not be possible at the program location. You may be asked to leave the program in order to isolate/quarantine.

We will make decisions about testing, quarantine location and duration, who must leave the expedition or program, or who is allowed to return based on guidance from the appropriate authorities and on a case-by-case analysis.

If a minor tests positive or exhibits symptoms of COVID-19 while on an expedition, we will follow the advice of a medical professional. In the event they need to isolate/quarantine, they will be required to depart the expedition and a parent or guardian will be required to take over their supervision and care, preferably within 24-hours, but no later than 48 hours. This may require a parent/guardian travel to the quarantine location to stay with the child. Any expenses not covered by Earthwatch's travel insurance policy will be the responsibility of the parent/guardian.

In the event you must depart due to testing positive for COVID-19, Earthwatch will help you find and get to medical care, arrange transportation, open an insurance claim, and/or consult with our emergency assistance provider as necessary. We will support you throughout any incident, but any expenses associated with a suspected or confirmed COVID-19 infection, including additional transportation, medical care or quarantine, such as accommodations for 10 days or more that are not covered by insurance will be your responsibility.

If you test positive within 10 days after your expedition you must notify Earthwatch. We will notify you should someone test positive on your expedition or within 10 days after the expedition. We will try to protect the identity of the person who tests positive, but please understand that may not always be possible.

#### **COMPLIANCE**

Your compliance and diligence will be required in order for these measures to be effective. If you do not comply with these expectations, or your behavior is judged to be a threat to the health and/or safety of you or anyone on your team, you may be removed from the expedition or program. You will be responsible for the costs associated with your early departure in this scenario and will not receive a refund or credit.

We appreciate your support and cooperation in helping us maintain the well-being of your team.
